### ORDER

As per paper read (1) the Dean, CCCES, Vellanikkara has submitted proposals for the commencement of the following academic programmes at CCCES, Vellanikkara in Revolving Fund mode.

- i. M.Sc. Ocean and Atmospheric Science
- ii. M.Sc. Climate Science
- iii. M.Sc. Environmental Science
- iv. B.Sc.-M.Sc.(Integrated )Biology
- v. B.Sc.-M.Sc.(Integrated )Microbiology

As per directions issued vide paper read (2), the proposals for conducting the above academic programmes in Revolving Fund mode was examined by a Technical Committee chaired by Director of Education on 26.07.2024. The Technical Committee vide paper read (3) has approved the proposals to conduct the programmes in Revolving Fund mode.

In the circumstances, the following orders are issued.

1. Administrative & Technical sanctions are hereby accorded for the commencement of the following academic programmes at CCCES, Vellanikkara in Revolving Fund mode under the Principal Investigatorship of Dr P O Nameer, Dean, CCCES.
  - i. M.Sc. Ocean and Atmospheric Science
  - ii. M.Sc. Climate Science

- iii. M.Sc. Environmental Science
  - iv. B.Sc.-M.Sc.(Integrated )Biology
  - v. B.Sc.-M.Sc.(Integrated )Microbiology
2. The conduct of the programmes in Revolving Fund mode is sanctioned with Corpus fund of Rs.10,00000/- (Rupees Ten Lakhs only) for each programme. Sourcing of Corpus funds for running the programmes in Revolving Fund mode will be realized in consultation with the Dean (Faculty of Agriculture) for providing funds from the PD account of College of Agriculture, Vellayani on recoupment basis.
  3. The Masters programmes will have an annual intake capacity of 20 students and the duration of the programmes will be 2 years. The integrated programmes will have an annual intake capacity of 30 students and the duration of the programmes will be 5 years.
  4. The Principal Investigator should maintain separate accounts on income, profit etc. for every activity for monitoring and evaluation of the scheme and submit the Revenue/Expenditure statement for Recurring/Non recurring costs in the RF account, every six months to the Comptroller, KAU
  5. The Comptroller, KAU will issue financial sanction on the basis of submission of request from the Course Coordinator detailing the budget requirements under the RC, NRC and salary Head of accounts for the current and ensuing financial years.
  6. The Principal Investigator should strictly follow the guidelines for the operation of RF Scheme issued by Kerala Agricultural University.
