The Officer i/c of Academic will make necessary arrangements for display of permanent board regarding definition of ragging, its penalty etc. in the campus especially in Hostels and College as detailed below.

### Permanent Board

Ragging means doing of any act, by disorderly conduct to a student of an educational institution which causes or likely to cause physical or psychological harm or raising apprehension shame or embarrassment to that student.

### Penalty

- Imprisonment for a term which may extend to two years and shall also be liable to a fine which may extend to ten thousand rupees.
- Will be suspended/dismissed from College
- Shall not be admitted in any other educational institution for a period of 3 years from the date of dismissal.
