Satisfying all other conditions, the lowest rate quoted will be accepted. However, the Dean has full powers to accept, reject or postpone the quotations without assigning any reason. The successful quotationer should start the work within 3 days of the receipt of work order. Payment will be effected by means of Cheque / Bank transfer on State Bank of India only. Security Deposit of 5 % of the total cost should be remitted at this office before effecting work and Income Tax if any to be recovered from payments will be collected then and there.
