The cover containing the quotation should be superscribed 'Quotation for the supply of 'Fruit Mill'. The quotationer should remit EMD of Rs. 1500/- at this office by cash/ DD along with quotation in favour of the Dean, College of Agriculture, Padannakkad.

The last date for receipt of quotation in this office is 3.00 P.M. on 27.01.2021. The quotation will be opened on the same day at 3.30 P.M. in the presence of the quotationer or their authorized representatives who may be present at the time. Late and incomplete quotations will not be considered. In case of the date of opening of quotation is a holiday, the same will be opened on the next working day.



Satisfying all other conditions, the lowest rate quoted will be accepted. However the Dean has full powers to accept, reject or postpone the quotations without assigning any reason. The successful quotationer should supply the item within 7 days of the receipt of firm's supply order. Payment will be effected by means of Cheque/Demand Draft drawn on State Bank of India only. Security Deposit of 5 % of the total cost should be remitted at this office before effecting supply and Income Tax if any to be recovered from payments will be collected then and there.

All Government rules on quotation will be binding on this also. Further details, if required, can be had from this office on all working days up to close of office hours.
